## ELIGIBILITY REQUIREMENTS

- DGCA, India Commercial Pilot License (CPL) valid during the tenure of the course
- Instrument Rating single-engine (IR)
- Minimum flying hours: 200 hours
- Minimum 100 hours as Pilot in Command (PIC)
- Valid class I medical
- ELP (English Language Proficiency) Level 4.

## PAYMENT CONDITIONS

Once you have submitted training request by email specifying the desired start time for training:

- Simaero will propose an approximate planning, and upon your confirmation, will send the invoice, payable in two (2) times:
  - 20% of the total amount to confirm the booking
  - remaining 80% ten (10) days before the start of the training.
- Payments must be paid by electronic transfer to Simaero.
- After the first payment, you will be asked for your required documents proving eligibility for the program.
- Simaero will then issue an invitation letter to facilitate the visa process.

## DOCUMENTS TO PROVIDE

To apply to this program, please provide digital copies of the following documents:

- A digital copy of your Indian Commercial Pilot License that is endorsed with your English language proficiency.
- A digital copy of your passport in JPEG format.
- A digital copy of your Class 1 medical certificate.
- A digital copy of the first and last pages of your logbook.
- A digital copy of your Radio Telephony Restricted license (RTR).
- A digital copy of your Flight Radio Telephony Operator's License (FRTOL).

# VISA APPLICATION CHECKLIST

## FOR INDIAN PASSPORT HOLDERS COMING TO FRANCE

Dear Pilot,

We kindly request your attention to the necessary procurement of a **Schengen visa** at a French Embassy in India prior to your visit to France.

For a successful visa application process, please book your appointment with the embassy and make sure to **bring all the following documents**.

## DOCUMENTS CHECKLIST

- ✔ **A Valid Passport**  
Your passport must be valid for at least 6 months beyond the end of your planned stay in the Schengen area. It must also have at least two blank pages for stamps.
- ✔ **A Visa Application Form**  
You must complete the Schengen visa application form online and print it out.
- ✔ **Passport-sized Photographs**  
You must submit two passport-sized photographs that meet the following requirements:
  - They must be taken within the last 6 months.
  - They must be in colour.
  - They must be against a white background.
  - Your face must be clearly visible from the front.
  - Your eyes must be open.
  - You must not be wearing sunglasses, a hat, or a scarf.
- ✔ **A Proof of Accommodation**  
You must provide proof of accommodation in France. This can be a hotel reservation, a rental agreement, or a letter from a friend or family member who is hosting you.
- ✔ **Simaero Terms & Conditions**  
You must provide the Simaero Terms and Conditions of Training and Services contract signed by both parties.
- ✔ **A Proof of Financial Support**  
You must provide proof that you have enough money to support yourself during your stay in France (min. EUR 120/ day). This can be in the form of bank statements, pay stubs, or a letter from your employer.
- ✔ **A Travel Insurance**  
You must have travel insurance that covers the entire duration of your stay in the Schengen area. The insurance must have a minimum coverage of EUR 30,000.
- ✔ **A Return ticket**  
You must have a return ticket to India or your home country.
- ✔ **A Cover Letter**  
You must write a cover letter explaining the purpose of your trip to France.
- ✔ **Documents related to your training**
  - The invitation letter from Simaero
  - Copy of your pilot licence
  - Copy of the proforma invoice with the deposit paid
  - Planning of the training
- ✔ **Other documents**  
You may also be asked to provide other documents, such as a birth certificate, marriage certificate, or divorce decree.
